NOTES FROM THE POTOMAC

Farm Bill Status: What was to be the 2012 Farm Bill, and later pushed into 2013, is now slated to be the 2014 Farm Bill. The four principals, Senators Debbie Stabenow and Thad Cochran, and Representatives Frank Lucas and Collin Peterson, appear to have reached some level of agreement on the major Farm Bill issues that had been outstanding. The intent is to share the terms of the agreement with other conferees prior to public disclosure—likely in early January after the Congress returns to Washington. In the meantime, the House has passed a short term extension of the Farm Bill, but the Senate is unlikely to take up that bill.

Although little has been made public, most of the conservation title provisions are very similar between the bills passed by the House and Senate, so very few surprises are expected. The final bill will almost certainly include a consolidation of easement programs, creation of a regional conservation partnership program, shrinking of the Conservation Reserve Program (CRP), and a slowing of enrollment in the Conservation Stewardship Program (CSP). The Environmental Quality Incentives Program (EQIP) will absorb the Wildlife Habitat Incentives Program (WHIP). Funding for conservation programs will be reduced compared to the Congressional Budget Office (CBO) baseline, but the amount is not known at this time.

One point of contention in the commodity title has been whether to use actual planted acres or historical base acres as a basis for determining benefits. Dairy provisions also need to be resolved.

The eligibility criteria for the Supplemental Nutrition Assistance Program (SNAP) (also known as food stamps) will be tightened somewhat in order to obtain savings.

Budget Deal and a User Fee for Conservation Planning: The House and Senate passed the Bipartisan Budget Act (HJR 59) that establishes budget limits for the next two fiscal years—2014 and 2015 (<http://thomas.loc.gov/cgi-bin/bdquery/z?d113:hj59>). The package, negotiated by Rep Paul Ryan and Senator Patty Murray, Chairs of the House and Senate Budget Committees, requires appropriations committee action to complete a set of appropriation bills or an omnibus bill before January 15th to avoid another government shutdown. With the budget and the appropriation bills in place, it will help avoid Congress lurching from crisis to crisis and get back to a regular order of business. However, the debt ceiling issue will be a topic of debate leading into February.

The enacted budget deal includes a provision that authorizes a user fee for conservation planning technical assistance. The fee would be capped at \$150 per conservation plan, but could be waived in the case of beginning, socially disadvantaged, or limited resource farmers or ranchers. It could also be waived for Highly Erodible Land (HEL) compliance plans or conservation plans to help comply with Federal, State, or local regulatory requirements. The fees would be deposited into a "Conservation Technical Assistance Fund" in the US Treasury, and would be administered by the Secretary of Agriculture. The details in the legislative language show that the proposal amends the Soil Conservation and Domestic Allotment Act (the 1935 Act) and retains the fees for subsequent use for conservation technical assistance, but subject to appropriations. This fee provision is estimated to raise a very modest \$4 million/year or \$40 million over ten years.

A number of organizations, including the National Association of Conservation Districts (NACD),

American Farmland Trust, National Sustainable Agriculture Coalition, and the National Farmers Union, have issued statements opposing the fee. A user fee could discourage some producers from seeking or updating a conservation plan, and could hinder the supportive relationship NRCS has with farmers and ranchers. It would be an added administrative burden for NRCS for collecting and accounting for all such funds.

Some other details in the Bipartisan Budget Act:

- An increase in retirement program contributions by new Federal employees.
- A reduction in the COLA adjustment for military retirees under age 62.

Cost of Living Adjustment: Retired Federal employees and entitled surviving family members of deceased Federal employees and retirees will receive a 1.5% Cost-of-Living Adjustment (COLA) effective December 1, 2013 and payable January 2, 2014. The COLA percentage applies both to participants in the CSRS and FERS retirement systems. The COLA applies if benefits have been received for at least one year, otherwise it will be prorated on a monthly basis.

Teamwork to Save Soil and Increase Production

As the deadline nears to submit one of these history vignettes and I start wondering about the subject, an incident will sometimes provide inspiration. It has happened again. Following our 50th high school reunion in North Carolina, two classmates, **Terry and Joyce Downes**, and I arranged for lunch in Philadelphia and a visit to the National Constitution Center. I asked the name of their town, and Terry responded: "Newtown. It's close to Washington Crossing." I remembered a short sighting of this famous Revolutionary War site, when three other SCSers and I drove up to Honey Hollow watershed to meet with the people organizing an environmental education center there.

The Honey Hollow watershed comprises some 840 acres in the Solebury Township of Bucks County, Pennsylvania. The farmers of Honey Hollow watershed had a long history with SCS. In 1939 some six farmers heard of the work of the new Federal agency, then visited farmers in a neighboring country who were working with SCS, and then contacted SCS for assistance. After the farmers agreed to work together, SCS staff prepared the conservation farm plans and helped in laying out the conservation practices, mostly but not limited to contour stripcropping.

The conservation showplace became a favorite with **Hugh Hammond Bennett**, who asked one of the six farmers, **P. Alston Waring**, to write about the collective conservation action in the watershed. Waring told the story in a USDA bulletin, *Teamwork To Save Soil and Increase Production*.

After World War II, as the suburbs spread, some of the farmers feared that the farmland would be converted to housing. Plans for a major four-lane highway and power lines that would bisect the watershed spurred the landowners to action. In 1969 the watershed was placed on the National Register of Historic Places. The **Crooks** family donated the Tuckamony Farm land and buildings for environmental education in 1980. In 1994 Bucks County Audubon Society purchased the adjacent farm, and in 1998 renovated a historic barn for the visitors center for their many environmental education programs.

ANNUAL REPORT ON FINANCES AND MEMBERSHIP

ARCSE Membership Report – Fiscal Year 2013 (ending June 30, 2013)

No. of members: 1056. Of these, 345 are lifetime members. There were 59 new members in FY13; of these 31 were complimentary. 15 of the 19 complimentary in FY12 joined in FY13. 48 members dropped at the cut-off on May 1, including four FY12 complimentary.

There are 784 newsletters distributed by email. There are 336 senior conservationists, a decrease of six from the 342 shown in the last report.

Monetary Contributions to ARCSE

ARCSE is fortunate to have a membership that continues to make generous contributions to support our operations. During our last fiscal year that ended June 30, individual contributions totaled \$1,442. The Board offers a big **thank you** to each of the 83 members who made a contribution.

The President's Message in the 2011 Nov/Dec. Newsletter included a special appeal to Life Members to make a contribution. 14 life Members contributed \$816 in FY 2013.

A review of the ARCSE records from FY 2002 through FY 2013 shows \$14,995 in contributions having been made by 469 different members. We can all be thankful for so many generous members that willingly contribute additional financial resources to support ARCSE. Cumulative individual contributions during that time have ranged from \$1.00 to a high of \$461, with 33 members contributing \$100 or more and an additional 134 contributing \$25 or more.

The Internal Revenue Service has determined that ARCSE is a 503(c)(4) organization. Unfortunately, contributions to 503(c)(4) organizations are not tax deductible by donors.

Marion Strong, Tempe: I have not been very active for some time. I have Neuropathy and pain in both legs below the knees, and it restricts my walking. My daughter, **Linda** and son, **Jim** each have summer homes at Ocean Shores, WA. I spent a few weeks this past summer with my daughter in her home. This enabled me to spend some time with Jim who comes to the ocean on weekends. My daughter and I visited some of **Ruth's** and my family in Indiana and Michigan earlier this year.

I was privileged to attend, with my daughters, **Linda Nelson** and **Marcia Middents**, the Memorial Service for **Mel Davis** in Yuma on Nov. 2. There was a nice crowd of Mel's neighbors and friends, some of which are Snowbirds. It was a moving experience. There was a good audience in attendance. However, I was the only SCS retiree, and there were no NRCS employees in attendance. It was disappointing for me.

(Since I, **Karl Klingelhofer**, am interested in Army Air Corps history and P-38s, I asked Marion Strong to comment on this experience, and he gave me the following.) I received my "Greetings" from my neighbors early in 1941. My first assignment was with the 51st Field Artillery Bn. at Camp Roberts, CA. In December of that year I applied for an assignment as an Aviation Cadet and was accepted. I was transferred to the Army Air Corps. I completed my training and received my wings and commission on Aug. 27, 1942. I was assigned for pilot transition to P-38s at McCord Field, WA.

I was the first pilot in my class to complete pre-flight training and make my initial flight in a P-38 on Sept. 14. My second flight was on the 15th. Everything went well until take-off. As I accelerated for take-off and just as my wheels left the runway my left engine caught fire. I cut the fuel and feathered the prop and prepared to climb. As I jettisoned my canopy, flames came into the cockpit through the ventilators and circled me in the cockpit. I climbed until I thought I was high enough to bail out but I could not roll the window down. My only choice was to stand in the seat, relax my body and let the slipstream carry me out. After my chute opened, I oscillated 90 degrees. As I stared down I was on the ground in the middle of a black unit encamped in Camp Murray, WA which is adjacent to Fort Lewis. I spent the next month in the hospital. I was the second pilot to successfully bail out of a P-38 and live to tell about. At the time of my accident, pilots who attempted to bail out of P-38s were being killed by the horizontal stabilizer. We had been briefed to roll down a window crawl out on the wing and drop off the trailing edge. I went overseas in January of 1943 and served my tour of duty in the Mediterranean Theater of Operation. I am a member of the P-38 National Association. The Association headquarters is located at March Air Reserve Base in Southern California. In May of this year the Association had their annual meeting at an old P-38 base near Ontario, CA. It was held in conjunction with an Air Show in which there were five P-38s flying.

I was able to attend the event with my daughter and son-in-law, **Marcia** and **Mark Middents**. It was very satisfying once again for me to hear that throaty roar of those turbo supercharged P-38s. One of the planes flying was named *Glacier Girl*. It had been dug out of the ice in Greenland and rebuilt. This plane was of special interest to me because my Flight Commander and later Squadron Commander had been a pilot in the flight from which *Glacier Girl* came. They had been ferrying a flight of P-38s in a flight with a B-17 to lead them when they became lost, ran out of fuel and had to land on the ice in Greenland. We had two of those pilots in my Squadron. It was very satisfying to get up close and personal with 38s again. Incidentally, that trip was my gift to myself for my 95th birthday.

Prepared by John Handler: My fourth year of retirement (2013) seemed to be themed around building things—physical as well as electronic: houses, patios, decks, databases, and railroads.

Yes, I built a house—not by myself, but with my Habitat for Humanity crew. We poured the footings on May 1st and finished on September 27th. Back at home, a new concrete patio and block wall replaced old wooden ones, and at the same time, ten concrete footings were poured for a new deck, which will be finished next spring. However (and surprisingly), the local lumber yard actually had a sale on decking materials in *November* (which even surprised its employees—"I guess we build decks year-round now" one of them mused, even in Minnesota). And the materials weren't the left over "junk"

lumber they were trying to clear out of inventory! So, I did manage to get started on the wooden part of the deck this autumn—something to look at this winter when the temperatures are below zero and dreams are of an early spring. Electric data base builds included two for the Goodhue County Historical Society—one was the Jail Register and the second was the Rural Schoolteachers. Both were index data bases that will end up on the Historical Society's web site (<http://goodhuecountyhistory.org/>) as a source for genealogical research. It was amazing what personal data were collected by the Sheriff as he was booking prisoners at the jail from 1859 to 1960—for example, hair and eye color, place of birth, parents' places of birth, ethnicity of the prisoner and his/her parents, and languages spoken. Those of you into genealogy, assuming that you have a less than reputable member in your lineage, may want to check your local jail registers for additional tidbits about your family member. One data base I am building at home is of the family's 35 mm slide collection. We always enjoyed the slide shows we used to have, but it became cumbersome to set up the slide projector and screen, darken the room, etc.—the electronic method of viewing on a computer, TV, or hand-held device is better. Plus, if the original slides ever get lost or deteriorate, then the images will still be preserved. Next year, we will caption them with names of family members and friends (while we still remember who they are!). I've found some amazing slides of my grandparents and father from the WW II era that I did not know existed. I wonder what I will find as I complete the scanning project this coming winter?

Building a railroad: the local model railroad club needed a new layout, and HO is my scale, so we collaborated on building a modular layout—six modules so far, assembled into a 16 x 5-foot layout for our Christmas show. The modular construction allows for a standard design and for portability (the largest module is 4 x 5 feet, and each is only 4 inches thick when the legs are folded under), yet its modularity allows enough flexibility to set up a differently-configured railroad at each model railroad show. Construction of more modules is planned for next year.

Soil Science is still in my blood (after a career of 37+ years, it's hard to completely let it go), so when the Wisconsin Society of Professional Soil Scientists (<http://wspss.wordpress.com/>) set up their soil pit display at Farm Technology Days nearby, I just couldn't resist volunteering to help staff it. Visitors to Farm Technology Days (<http://www.wifarmtechnologydays.com/>) seek out the pit and engage in lively discussions about what they are observing below the surface. As usual, there are as many opinions as soil scientists and visitors, but of course, those discussions further our knowledge of soils and advance the science of pedology. I think I tallied more hours on snow and ice removal this year than lawn care! The final time I shoveled snow last spring was on May 9, and the first shoveling this autumn was November 14. What a short summer, even for Minnesota.

Tall Ships visited Duluth harbor in July (<http://www.visitduluth.com/tallships2013/>), and we booked a day-sail on one of them. But with our luck with weather this year, our ship was struck by lightning out on Lake Superior and never even made it to the Tall Ships event! (It's hard to sail a ship when the masts have been vaporized.) Even though other ships' captains were very

accommodating by accepting extra passengers onto their ships for day-sails, there simply weren't enough ships or times for everyone, so we missed out on the day-sail. The tall ships are expected back in Duluth in 2015—anyone have a weather report? Some of the ships offered on-board tours, which is like stepping back 125 years or so when you cross the gangplank. However, the best memory of the day was the look on one visitor's face when the answer to his question "When was the last time that cannon was fired?" was "Thursday." Cannon fire is the salute ships give when another tall ship first enters the harbor.

Between August 1st and mid-September we had no rain (but no snow, either), which didn't fare well for colorful leaves this past autumn—the leaves dried out and just turned brown. He was a distinguished Lt. Governor in 2006-2007 for Division 21 and Governor in 2010-2011 for the Nebraska-Iowa District. The District encompasses 193 clubs and 6,400 members.

The Tom and Nancy Osborne's Team Mates Mentoring program is school-based, where a mentor meets with a student one hour a week during the school year. He is currently mentoring his seventh student and is known as the Ambassador for Team Mates throughout Nebraska and Iowa. For his efforts, he was named Team Mate Mentor of the Year, and in 2011, he received The Carmen and Tony Messineo Community Service Award for outstanding Community Service.

Gus lived in 10 communities as part of his National Resource Conservation Service career tour and gave back to each community with his talent and time. For example, he was involved in outside-of-school activities, school activities, service clubs, and churches. Congress and Your Health Insurance: Washington, DC (NARFE Magazine, Dec 13) **Representative Dave Camp**, R-MI, is sponsoring H.R.1780. The bill provides that the only health plans that the federal government may make available to the President, Vice-President, members of Congress and federal employees are those created under the Patient Protection and Affordable Care Act or offered through a health insurance exchange. The bill would remove federal employees from the Federal Employees Health Benefits Program (FEHBP) and place them in the health exchanges under the Affordable Care Act. The bill has 30 R co-sponsors. It is presently in conference committee.

Soil Conservation Set-up

Moving toward completion of the reorganization of the Soil Conservation Service, D. A. Williams, administrator of the Soil Conservation Service, has announced the designation of State and Territorial Conservationists who will head SCS work in 29 States and Alaska. Selection of men for the remaining States and Territories is expected to be completed soon.

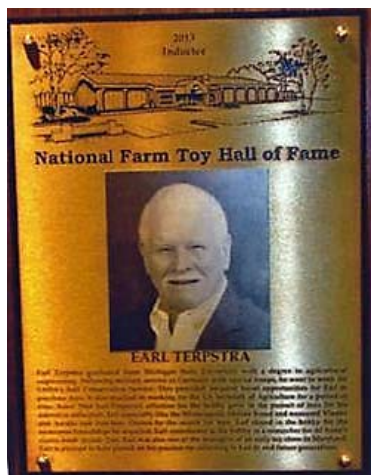
In the reorganization plan announced by Secretary of Agriculture Ezra Taft Benson on Nov. 2, seven SCS regional offices were abolished and state offices of the Soil Conservation Service were given additional responsibility for direction of work in each state. In all positions announced today, the present state conservationist has been appointed to continue administration of the SCS program.

Mr. Williams also announced that SCS staffs in state offices will be increased to enable them to carry the additional responsibilities and work load.

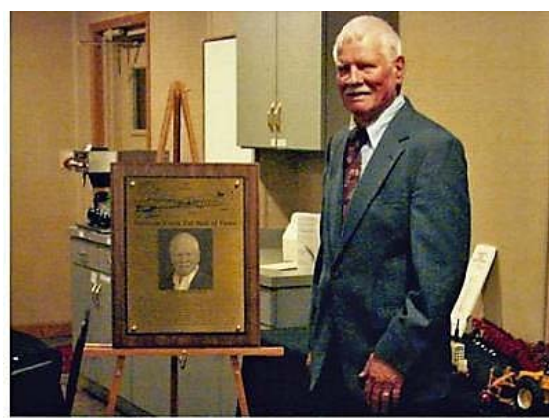

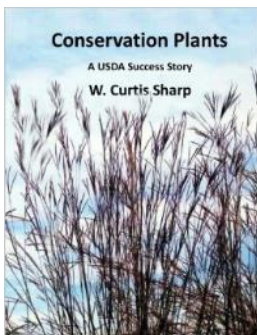
