NOTES FROM THE POTOMAC

Congress Still Bickering - As of this writing, Congress has yet to agree on (1) A one-year extension of long-term unemployment benefits; and (2) a one year 2% Social Security payroll tax holiday. Also, held hostage is the "Doc Fix" legislation needed to provide Medicare reimbursement rates from being cut 25%. Congressional leaders expect a compromise to emerge with a deadline of December 30, 2011. (Ed. Note - As of December 22, a temporary extension has been agreed upon.)

Super Committee Fails - So now What - The Budget Control Act enacted last summer provides for an alternative avenue to achieving the \$1.2 trillion in required savings in the form of automatic across-the-board cuts or sequestration beginning January 2, 2013. Don't be surprised if Congress repeals this provision during the coming year.

Estate Law Changes - The Tax Relief, Unemployment Insurance Reauthorization, Job Creation Act of 2010 (the 2010 Tax Act) made significant changes in the income tax code federal estate tax. An interesting change is the "portability" provision, that allows any unused gift and estate tax exemptions of a deceased spouse, to be transferred to the surviving spouse. This legislation expires beginning January 1, 2013.

The USDA Farm Bill 2012 - Three major groups are battling for the ear of the House and Senate Committees developing the updated Farm Bill: (1) Farm and Commodity groups; (2) Conservation/Environmental/Wildlife groups; and (3) Supporters of spending on food stamps and nutrition programs for the poor. In USDA, the serious proposals address crop revenue programs and enhanced crop insurance. Such proposals are designed to eliminate commodity program payments (direct farm payments and countercyclical payments). Commodity, conservation, nutrition, and crop insurance compose 99% of farm bill spending.

Groups and organizations, recognizing the budget cuts forthcoming, are supporting a reduction in the number of eligible acres for the Conservation Reserve Program, capping the Conservation Stewardship Program, and maintaining current spending level for NRCS's EQIP.

It was in 1973, almost four years after his retirement, that **Don Williams** [former SCS Administrator] took action to determine if there was any interest in forming an SCS retiree's association. Wayward Cow Tale Is No Bull

We are a County of individuals, most of whom work outside the County. On this night it was a coming together of Citizens to try and do what was right. The outcome was not what we would have chosen but everyone was working together for the common good.

Now, where is the bull? **George** and friends searched unsuccessfully through the night to locate him. They gave up and went home to get some sleep.
