## NOTES FROM THE POTOMAC

**Budget Year 2012** - The House adopted, on April 15, Concurrent Resolution 34, Budget for Fiscal Year 2012, authored by Budget Committee Chairman, Rep. Ryan, R-WI. The Resolution would reduce spending by \$4.4 trillion over 10 years. This is the opening shot addressing the U.S. debt and the Affordable Care Act. So far, the Senate has not chosen to act on the Resolution.

**Fiscal Year 2012 Agriculture** - The House of Representatives Appropriation Committee approved a \$125 Billion Agriculture Appropriation Bill (H.R. 2112. NRCS Conservation Programs were reduced significantly; Conservation Stewardship by \$210 million and EQIP by \$350 million. H.R. 2112 will now move to the Senate where the Democrats will likely have different priorities and budget goals.

**Possibility for 2012 Cost-of-Living Adjustment (COLA)** - An adjustment for federal annuitants in 2012 depends on whether the (CPI-W) for the third quarter (July, August, September) of 2011 is higher than the highest previous third quarter, which occurred in 2008. The CPI-W for April 2011 was 2.9% above the 2008 third quarter average. If the 2.9% remains unchanged through the third quarter this year, it will result in a 2.9% COLA for federal annuitants.

**IRA Custodial Agreements** - Individual Retirement Accounts (IRA) Custodian Agreements, either Traditional or Roth, may be more restrictive than Internal Revenue Service (IRS) rules. Read carefully the terms and conditions in this document binding you or you or your beneficiaries. For example, does the Agreement permit your designated beneficiaries to stretch the IRA distribution over his or her life expectancy, as permitted by IRS?

This year the hay gets rained on every day and is so moldy **Mary Ann** has to brush the mold off the hay so the cows can eat it. But the horses can't eat it even after she bushes it off. When **Mary Ann** gets done she is so covered with mold she has to hose herself down before coming in the house.

The pastures are so wet we don't dare put the horses or cows out on a field. They would sink up to their knees and **Mary Ann** would spend full time pulling them out of the mud. Since we can't get the animals out on pasture **Mary Ann** has to take a scythe, cut the grass, and carry it to the horses.

The other day **Mary Ann** went out to scythe grass for the horses and I couldn't figure out why she wasn't sinking into the ground. Especially when she is carrying a big load of grass. I got the scope out and watched her out the window to see how she was avoiding sinking in. Then I saw she was wearing snow shoes.

We haven't been to town in over two months with a vehicle. Luckily, we have lots of ground squirrels, wild onions, and dandelions to eat and fresh milk to drink. We ran out of table salt so **Mary Ann** brought in a block of cow salt and sat it in the middle of the table. When we need some salt we lick the block. One good thing is it really restricts my salt intake. Every day I shoot enough squirrels for us to eat. **Mary Ann** is so happy that I'm able to get enough ground squirrels. Hunting ground squirrels takes all my time when I'm not on the phone or else I would be able to help **Mary Ann** with the ranch work.

**Mary Ann** had to take her two pack mules to Three Forks which is 70 miles from us to get seed so we can get the fields planted. It's a slow process planting the fields. Since the fields are so wet **Mary Ann** has to plant everything by hand and having to wear snow shoes really slows her down.

One good thing that happened with all the rain is that we needed to seed some native grass in an area that was drought out several years ago. I got a copy of the Rangeland Seeding Standard and Specs from NRCS and gave it to **Mary Ann**. **Mary Ann** did her best to follow the

specs but she wasn't able to scarify the ground because it was so wet and the tractor is broke down any way. **Mary Ann** was about a month late in getting it planted. We checked with range con **Dennis Froeming**. He said we would have to cross our fingers since we weren't following the specs exactly. But **Mary Ann** had no choice. She took her whirligig hand seeder and seeded the area. The grass is growing like mad. I think every seed germinated. I called NRCS about getting an EQUIP contract. They tried to come out to look at the site to see if it would qualify, but the road is so muddy they weren't able to make it out. They tried to make it on a four wheeler but it's still buried about half way out here. I called the State Conservationist **Joyce Swartzendruber** to see if they could rent a helicopter so that **Marni Thompson** could check the field. When **Joyce** asked me how many acres we were talking about and I said 40, I heard two days later she was still laughing.

NRCS is working with the Louisa County Historical Society and Thomas Jefferson Soil and Water Conservation District to dedicate an historic marker formally recognizing Virginia and its important role in the development of what has become our modern soil survey and the soil conservation movement in our country. NRCS will also take this opportunity to commemorate the completion of Virginia's initial soil survey mapping more than 100 years after Mr. Bennett's first fieldwork began.

The ceremony will be held at the Louisa Arts Center Auditorium with the unveiling afterwards on the grounds outside. Retirees who are part of our proud history have been invited to attend.

This event was publicized by use of several means. One method was the use of "Save the Date" cards. These cards read as follows:

### Save the Date July 15, 2011

Join the Louisa County Historical Society and the USDA Natural Resources Conservation Service in recognizing Virginia as the birthplace of modern soil conservation.

"The damaging effects of soil erosion were in evidence to right and left through the rolling farm country encountered in North Carolina, Tennessee, and Virginia during my first two years of surveying, but it was not until 1905 that I began to understand just what was taking place on the land." — Hugh Hammond Bennett

In 1905, Hugh Hammond Bennett, "the father of soil conservation," conducted a special soil survey in Louisa County, Virginia, through which he came to understand the link between soil erosion and degradation of soil quality. Mr. Bennett characterized the Louisa County survey as an epiphany about erosion processes and referred to that study throughout his career as he campaigned nationally for soil conservation.

One hundred six years after that first fieldwork began, Virginia's initial soil survey mapping is now concluded. Surveying 26 million acres required a huge federal/state/local partnership. Today, this soils information can be easily accessed online at [websoilsurvey.nrcs.usda.gov](http://websoilsurvey.nrcs.usda.gov).

Join us in the Arts Center Auditorium at 2 p.m. on July 15, 2011, for a look back at Louisa's place in Virginia soil conservation history and a look forward at the future of soil surveys.

The American Society of Agricultural and Biological Engineers (ASABE) recognized USDA's Small Watershed Program as a National Historic Engineering Landmark in Oklahoma City on May 17<sup>th</sup>, 2011. The ceremony was held in conjunction with the 12<sup>th</sup> National Watershed Conference conducted by the National Watershed Coalition (NWC). This was only the 57<sup>th</sup> such designation made by ASABE since 1926, but the first time a "program" was so honored. Usually it has been a significant development or project such as the John Deere plow, the cotton gin, vegetated waterways, and the skid steer loader. These projects have typically protected people's lives and property and have improved the quality of life and rural community environment.

**Larry Caldwell** moderated the ceremony, and **John Peterson** was one of the speakers providing some program history and a national perspective. NRCS Chief **Dave White** and ARS Administrator **Dr. Ed Knipling** also spoke. Dedication plaques have been located at the NRCS State Office in Stillwater, OK, the ARS Hydraulic Engineering Research Unit near Stillwater, and a granite monument was placed at the Agriculture Building on the State Capital Complex in Oklahoma City. **Larry & John** have also been asked to speak at the ASABE Annual Meeting on August 8<sup>th</sup> in Louisville. It would be nice if this recognition of the benefits of this tremendously successful conservation program would help restore people's support for it. With all the flooding we have experienced this year, on the Mississippi, Missouri and Souris, Red Rainey Rivers; such a program is sorely needed. Where watershed projects have been completed as planned, there is far less need for federal disaster assistance in times of flooding.

**Glen Johnson** says, "Got back to ND 2 weeks ago, what a change from hot dry AZ. South of the Des Lacs River about 30-40% of cropland is seeded (no wind erosion this spring), North of there many fields and farms have nothing seeded. Sheet and rill erosion is extreme. We had 2" of rain last Monday afternoon and water is still standing in my yard on level ground. Many of the fields I see are 30-50% water. I just came from Minot where the Souris is hitting new record flooding, the town is divided, only trucks allowed on the only usable road between north and south side. Most retail business is on the south side so those on the north side have no grocery, hardware or grocery stores and this will go on til mid July at least. One thing is for sure it should be a short harvest this year. " Thanks, **Glen**.

## SENIOR CONSERVATIONIST CHRONICLE

**Kenneth L Williams** was born March 24, 1927, and raised on a dairy farm near Vineyard, UT (about forty miles south of Salt Lake City). He attended public schools through high school. He then enrolled in Brigham Young University. Following his freshman year, he was employed as a W.A.E. Conservation Aid by the Soil Conservation Service (SCS). While preparing to return to college he was encouraged to take the Civil Service Examination for a position of Student Trainee. He passed and SCS employed him at several locations in UT. He graduated from "The Y" in 1951 with a Bachelor of Science degree in Agronomy.

**Ken** married **Jewel Frampton**, his college sweetheart, in 1950 and spent the next two years managing a cattle ranch for her father. He returned to the SCS as a Soil Conservationist in Layton, UT. Between 1954 and 1961 **Ken** served as District Conservationist in Moab, Huntington, Castle Dale, and Beaver, UT. He then accepted a job as Assistant Area Conservationist, with headquarters at Sebastopol, CA. There was a sizable small watershed program in this area; this was his primary responsibility. In the fall of 1963, **Ken** enrolled at the University of Michigan in a Masters program that focused on developing methodologies that entities could use to make better use of economic analysis in resource allocation and utilization policy development. Upon completion, **Ken** was assigned as area conservationist at North Vernon, IN, from June 1963 through January 1965 when he was assigned as State Resource Conservationist for AZ. He was reassigned as Assistant State Conservationist for Operations and Management in Phoenix in 1966. He was promoted to State Conservationist for NM in October 1968 where he served until April 1972. He was then assigned as Western States Field Representative and Director of the West Regional Technical Service Center in Portland, OR. **Ken** transferred to the National Office in 1980 as Deputy Chief for Planning and Evaluation. The most pressing part of his job at this time was completion of the National Conservation Program along with a statement of policy by the President transmitting it to the congress. The primary objective for the program was to ensure that in 2030 our nation could still meet its food and fiber needs. The documents were sent to Congress by President Reagan in December 1982. **Ken** retired March 31, 1983, and returned with **Jewel** to their home in Portland. They moved to Orem, UT, November 1992. Sadly, **Jewel** passed away in February 2001.

**Ken** has always been grateful for **Jewel** and their family. They had three children, a daughter **Joan**, then a son **Steven**, and then another daughter **Janet**. He extends them his thanks and his gratitude for their willingness to accept the many moves they made and for the support they gave in his career. **Joan**, **Steven**, and his wife **Katie** live in Orem. **Janet** and her husband **John Barringer** reside in Matthews, NC. On his 83<sup>rd</sup> birthday **Ken** considered his greatest achievement in life to be his three children, fifteen grand children, and thirteen great-grand children.
