## NOTES FROM THE POTOMAC

**The Congress**—With November only a few days away, much of Washington is focused on the election and what comes next, depending on which party has a majority in the Senate. Regardless of election outcomes, appropriations will require attention during the lame duck session before the end of this year's session of Congress. At this time it looks like either an omnibus appropriation bill or a continuing resolution will be the avenue of choice for Congress. An omnibus bill would likely provide somewhat greater funding for the NRCS conservation operations account compared to a continuing resolution that limits funds to the FY 2014 level. The dollar amounts were provided in the last issue of the ARCSE newsletter.

Efforts are underway to have the lame duck session include an extension of tax credits, including one for conservation easements. There is broad bi-partisan support for this bill, but it is uncertain whether Congress will want to tackle a tax bill during the brief time available.

**NRCS**—In addition to the many on-going things at NRCS, considerable effort has been underway to develop and finalize a number of rules associated with conservation programs in the Farm Bill. A rule is expected to be published soon for each of the following programs: Conservation Stewardship Program (CSP), Environmental Quality Incentive Program (EQIP), and the Agricultural Conservation Easement Program (ACEP).

NRCS is expected to announce in mid-November the project selected for funding under the Regional Conservation Partnership Program (RCPP). Of the almost 600 pre-proposals submitted earlier, 231 projects were invited to submit full proposals. The agency has posted information on strengths and opportunities for improvement found in the evaluation of pre-proposals submitted. RCPP is intended to boost conservation delivery and leverage the Federal investment through partnering with other organizations that work with producers.

Chief **Jason Weller** indicated that NRCS is also developing a rule that would outline how NRCS may be able to use science-based technology to make compliance determinations without having to make a complete site visit. It is part of agency efforts to streamline the process of making determinations. This proposed rule will be open for public comment after it is published, likely in early November.

**FY2014 Budget**—Treasury Secretary **Lew** and Budget Director **Donovan** released FY 2014 final budget results that show significant and continued progress in reducing the deficit. When measured in outlays, the deficit was about \$200 billion less than FY 2013 and \$165 billion less than forecast in the budget. NRCS outlays were \$118 million less than FY 2013 and nearly \$850 million less than budgeted for FY 2014. Some of the budgeted resources will be spent in FY 2015 since Farm Bill resources are now "no year" funds.

**Waters of the United States (WOTUS)**—EPA and the US Army Corps of Engineers have extended the comment period to November 14<sup>th</sup> on the proposed rule that defines the waters within the jurisdiction of the Clean Water Act. The proposed rule, and a related interpretive rule, have been controversial in that while the stated intent was to provide clarity, a number of groups have said that it amounts to regulatory over-reach. This issue is not likely to subside in the months ahead and will likely end up back in the courts.

**Cover Crops and Soil Health**—Over 40 organizations have signed on to a statement recently delivered to USDA that provides a common vision for cover crops and soil health. The statement calls upon USDA to broadly support cover crops and soil health through a comprehensive strategic plan with clear, outcome-based goals for a wide range of USDA (cont'd)

policies and programs. Organizations included producer groups, conservation groups, farm suppliers, and several foundations. The statement can be found at

## PRESIDENT'S AWARD FOR OUTSTANDING COMMUNITY SERVICE, 2014

Name: **Scott Hoag, Jr.**, Bozeman, MT 59718

**Dick Gooby** presented the President's Community Service Award to **Scott Hoag** at the Montana retirees' breakfast, September 3<sup>rd</sup>, 2014. There were 24 retirees and wives at the breakfast. Scott and his wife **Nancy** were really appreciative of the award. Scott is a native of Montana and received his MS in Agricultural Economics from Montana State University. He started his career as a Soil Conservationist in 1972 and retired with 33 years of service after holding positions in Montana (twice), New Mexico, Pennsylvania, Washington DC (twice) and North Dakota (STC). He participated on three short term foreign assignments to India,



Nigeria and Jordan providing technical assistance for water resources development and natural resources conservation. Scott retired from National Headquarters in 2001.

Meanwhile, Scott was asked if he might repair two local shelters (in Bozeman) for battered women and their children, and though she'd never been keen on volunteering, before long Scott's enthusiasm began to nudge his wife **Nancy** to do the same. There were people all over this country—many of them single mothers—without a place to live and raise their children. Within days, an entirely different vision for Scott's and Nancy's retirement began to replace all the plans they had made for a big home and expanded travel. It no longer made sense to either of them to simply spend their resources and retirement on themselves: they would build decent, safe, and affordable homes for people who could not, given their circumstances, build one on their own.

In 2008 Scott and Nancy sold their Bozeman home and 75% of what they owned, purchased a small condominium in order to store what they had kept, and then purchased an RV (5<sup>th</sup> wheel) and spent most of the next four and one-half years volunteering with Habitat for Humanity (HfH). Scott and Nancy traveled back and forth (three times) across the US helping to build homes for families residing in Washington, Oregon, New Mexico, Texas, Louisiana, Georgia, Ohio, Virginia, North Carolina, Florida and Montana. Scott participated in 33 building projects, working on more than 60 homes.

Children find stability in their community and their schools and self-esteem in a stable home environment. When these children are provided with a stable home environment and an address that doesn't change every several months, they compete in sports, join girl scouts and boy scouts and participate with youth groups at their church.

One thing Habitat volunteers say at the start of each day is "Habitat is not a hand out, it is a hand up!" As a result of home ownership, single mothers have started their own businesses. One single mother now owns her own burrito shop in Colorado; another has created a log chinking business that provides for her children and herself. In Port Townsend, **Amy** was able to build her photography business. Scott and Nancy worked with Amy while building her home to create a dark room for her where there might otherwise have been a 3<sup>rd</sup> bedroom she and her little boy did not need. Prior to becoming involved with Habitat, Amy was a single mom with a 3 year old who had had 21 operations, and she was working as a waitress in two restaurants. Scott suggested she apply for an HfH house. The following year when Scott and Nancy returned to Port Townsend to build again, Amy came running from the kitchen, threw her arms around Nancy and cried "I got my house." Later, Scott had the privilege of working on Amy's house as a volunteer. As a side note, something like 95% of the kids in HfH homes graduate high school and go on to college.

Scott has also volunteered with Eagle Mount in Bozeman providing recreational opportunities for physically and cognitively challenged young people and adults. Scott worked with folks in the therapeutic riding program and the adaptive ski program for three years.

Scott was nominated for a position and was elected by the Bridger Bowl Association to the Bridger Bowl Board of Directors. Bridger Bowl is a family-oriented, World Class ski area providing affordable skiing for residents of the Gallatin Valley and visitors from across the United States.

He points out that none of this would have been possible if not for his wife's support and their agreement to sell their home and buy a 5<sup>th</sup> wheel and pick-up and go "on the road" for Habitat for Humanity. "It takes a team," he said.

### **Hans Albert Einstein and the SCS**

When the Soil Conservation Service was created in 1935, it inherited the erosion experiment stations established by **Hugh Hammond Bennett** in the late 1920s. SCS augmented those activities with hydrologic and hydraulic research to understand the processes of erosion, water and sediment movement, and flooding in small watersheds. The ultimate objective was to aid in the design of conservation practices. One area of considerable interest was the Southern Piedmont, where over a century of clean-tilled cotton growing on rolling lands had taken its toll. In upstate South Carolina, SCS consolidated research along with demonstration projects and management of land utilization projects.

The SCS took the opportunity to hire a young scientist from Switzerland who was already making contributions in the study of bedload transport. Though **Hans Albert Einstein** preferred to make it on his own, without a boost from his famous father, the father did in fact write to **Gilbert C. Dobson**, acting chief of SCS's Sedimentation Division, saying, "I should be very happy, if my son could take part in the solution of the important water-regulation-problems of this country." In 1938, Hans Albert, not yet a citizen of the United States, went into the employ of the state of South Carolina, where the state and SCS were cooperating in the construction of an outdoor hydraulics laboratory on the Enoree River, near Greenville. Since the Enoree seldom ran full for extended periods, young Einstein also studied a smaller stream, Mountain Creek, at the foot of Paris Mountain. For these studies he built a mobile laboratory by mounting sampling equipment on a truck.



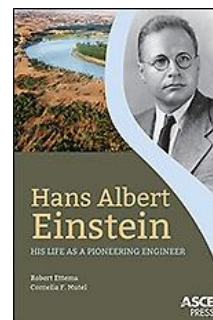

When SCS closed the Greenville laboratory due to wartime funding cuts, Einstein moved to the California Institute of Technology where SCS had funded construction of an indoor hydraulics laboratory and had a cooperative research project with Cal Tech. Again, the ultimate objective of the research was the design of soil and water conservation measures and structures. At Cal Tech and after moving to the University of California-Berkeley, Einstein continued to work on the publication that would be issued as ***The Bed-Load Function for Sediment Transportation in Open Channel Flows***, U.S. Department of Agriculture Technical Bulletin 1026 (1950).

One can read an engaging and detailed account of Einstein's SCS career as well as an account of his childhood, family life, and post-SCS career in Robert Ettema and Cornelia F. Mutel's, ***Hans Albert Einstein: His Life As a Pioneering Engineer*** (ASCE Press, 2014). 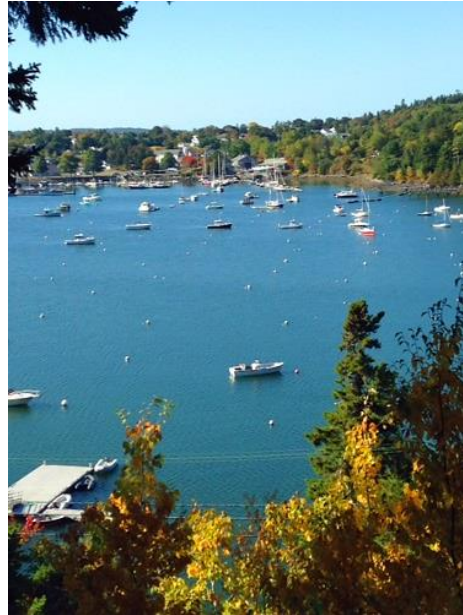

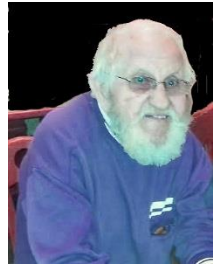

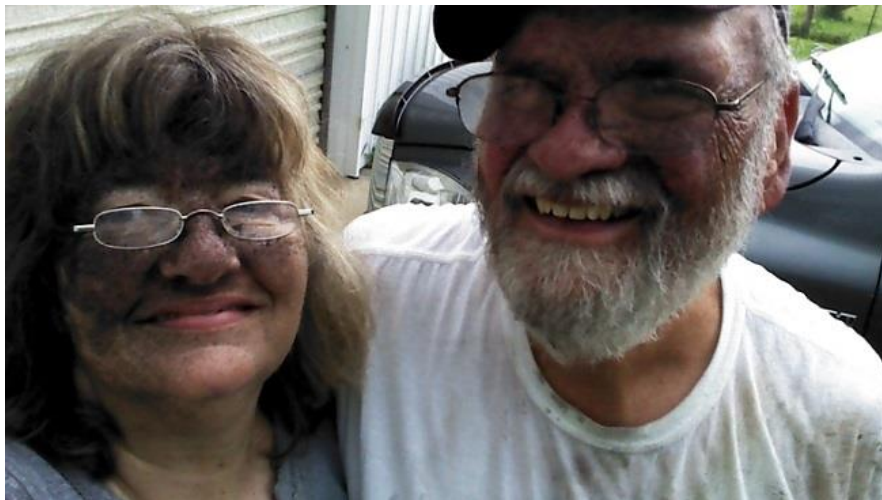

## SENIOR CONSERVATIONIST CHRONICLE

**Keith O. Schmude, Ph.D.**

Senior Conservationist **Keith Schmude** was born in his family's home on their dairy farm in Poygan Township, Wisconsin. Keith grew up on that farm and attended local schools. He graduated from Omro High School (Omro, Wisconsin) in 1949. His father was an early cooperator with the local conservation district. Keith has said that it was his experience helping **George Framberger** (the District Conservationist) lay out terraces and seeing development of the soils map for the farm that convinced him that a career in soil science and conservation was for him.

Keith planned to enroll in the local state college in Oshkosh after high school and worked to earn tuition money. He was drafted into the U.S. Army in 1951 and served in Korea until separated from active duty in 1953 and was honorably discharged in 1959 after serving in the U.S. Army Reserve for six years. While in Korea, he served as a Combat Infantry Squad Leader for the 45th Infantry Division. For his service he received two Bronze Stars, the Combat Infantry Badge with two overseas bars, a United Nations Service Medal, and a commendation ribbon with metal pendant for Meritorious Service. Keith was anxious to start college. He arrived home after his discharge on a Friday and was sitting in class at Wisconsin State College the following Monday.

It was during his studies at Wisconsin State College that he met **Barbara Wilson** who became his wife before he transferred to the University of Wisconsin-Madison to complete his undergraduate work. They married June 18, 1955. Keith graduated with Senior High Honors with a B.S. in Agriculture. He completed a Master of Science program at the same school in 1959 in the discipline of Soil Genesis and Classification.

Keith's career with the Soil Conservation Service (SCS) began in Wisconsin in 1958. From 1958 to 1968 he rose from GS-5 to GS-11 Soil Scientist. He was a soil survey party leader and was author of two county soil survey publications. In 1968 he accepted a promotion to Assistant State Soil Scientist for West Virginia. He served in that job until 1970 when he was selected State Soil Scientist in-place. Keith worked there until 1976 when he was promoted to the Inventory and Monitoring (I&M) Division within SCS Headquarters. He entered on duty on July 4, 1976. In 1978 Keith was awarded a Ph.D. degree in Interdisciplinary Studies from West Virginia University. His dissertation involved five disciplines (soil science, civil engineering, agronomy, economics, and geology) and the use/utility of soil survey information in land use planning. Keith served in the I&M Division until he retired in 1988.

Keith has received many awards during his career. In 2004 he has honored by his high school by being added to the Omro High School Wall of Fame. Keith and Barbara have seven children, 14 grandchildren, and two great-grandchildren. They continue to live in the home in Fairfax County, Virginia, they moved into in 1976. Next year they will celebrate 60 years of marriage and are making plans for that celebration. Keith and Barbara enjoy traveling to visit their children as well as gardening and wood crafting.

He graduated from WVU in 1940 with a degree in agriculture and began work in Taylor County with the Farm Security Administration, the forerunner of the Farmers Home Administration (FHA). In 1942, John volunteered for duty in the U.S. Navy as a radio man on the battleship USS New Jersey, where he served in more than 20 combats in the Pacific Theater, including the Battle of the Philippines. He received nine major battle stars. John took great joy in being on the battleship's radio, and being the first person on the battleship to learn the Japanese had surrendered.
