## NOTES FROM THE POTOMAC

**Congress**—The Congress is in August recess, so appropriations continue in a holding pattern. Congress will be in session after Labor Day for part of September, but will then be out for the election and be back in session for November. During this limited time in session, Congress must complete the appropriation process to keep the government open for the new fiscal year. An omnibus appropriation bill is likely later in the year with short-term continuing resolutions until then.

**NRCS**—Chief **Jason Weller** announced the investment of nearly \$7 million in funding for agricultural wetland mitigation banks in 10 states. This USDA program helps partners develop mitigation banks that restore, create or enhance wetland ecosystems. Then producers can buy wetland credits offsite to make up for unavoidable wetland losses on-site. Wetland mitigation banking was created in the last Farm Bill and is structured to use a market-based approach. This program announcement includes work in Georgia, Illinois, Iowa, Michigan, Minnesota, Missouri, Nebraska, North Dakota, South Dakota, and Ohio.

**CSP**—NRCS continues working on the makeover of the Conservation Stewardship Program (CSP) to make it more user-friendly and similar to EQIP. One of the improvements concerns conservation enhancements—making a stronger linkage between the conservation practice and the expected benefits. This will help farmers and ranchers see more clearly the effects of practice implementation. CSP is now the largest land conservation program in USDA, covering about 70 million acres.

**USDA**—The Departments of Defense, Agriculture, and Interior announced the addition of three military bases to the Sentinel Landscape Partnership to improve military readiness, protect at-risk and endangered species, enhance critical wildlife habitat, and restore working agricultural and natural lands. This joint effort uses USDA's conservation programs to protect viable farmland, rangeland, forestland and grasslands from development around these military bases and training sites. The three additions are Avon Park Air Force Range, Florida; Camp Ripley, Minnesota; and training grounds in Eastern North Carolina. More information can be found at

**RCPP Project**—An interesting video was recently released of a Regional Conservation Partnership Program (RCPP) project in Washington State intended to help address unhealthy water temperature and fecal coliform in the Newaukum Creek. The principal organizations handling this project are the American Farmland Trust and King County Conservation District using NRCS RCPP resources. **People**—Land O' Lakes has hired **Tina May** as Senior Director of Sustainability. Tina was the lead conservation staffer for Senator **Debbie Stabenow**, Chair of the Senate Agriculture Committee during the 2014 Farm Bill. Tina also was Chief of Staff for the Office of the Deputy Secretary of USDA during rulemaking for the Farm Bill.

**Callie Eisenberg** has left NRCS to go to the Environmental Defense Fund. Callie had been a key point of contact in NRCS for constituency groups as well as her work with legislative affairs.

**Election**—An item of note is that Congressman **Tim Huelskamp** from the huge agricultural 1<sup>st</sup> district of Kansas lost in this year's August Republican primary. A couple of years ago, Huelskamp was removed from the House Agriculture Committee and the House Budget Committee in a dispute with then-Speaker **John Boehner**. He voted against the 2014 Farm Bill and also took several actions in disagreement with GOP leadership in the House. A number of agricultural groups opposed Huelskamp in the primary.

## FROM THE PRESIDENT

Today is not my lucky day. I am sitting in the Louisville airport waiting for a plane with mechanical problems—better than in the air—much better. I have been at the airport since 5:45am and will get home at about 2am tomorrow morning. Remind me to drive to the SWCS/ARCSE meeting next time.

My thoughts are on water because the SWCS conference was about "Managing Great River Landscapes." The opening speaker was memorable. He started picking up trash in and on the Mississippi River when he was a barefoot kid in overalls. He is now 32 years old and heads a nonprofit with a budget over \$10 million. He organizes thousands of volunteers and has removed some 8 million pounds of garbage from 23 rivers. He was hailed as "America's hardest working person" when recognized as a "point of light" by **President Bush**. All four living presidents gave **Chad Pregrache** a standing ovation. Chad proved that one person, even a very young person, can make a difference. I will never forget the privilege of listening to this young environmental hero.

I am also thinking about the mighty St. Lawrence River which flows by my dock. More than a quarter of the fresh water reserves in the universe are in the St. Lawrence River system. Where we are in the 1,000 Islands area it's not just fishable and swimmable, it's drinkable. While the world is short of water, we have an abundance in NY. As we all know, large parts of the world are so water-short that families spend more than half of their income just for drinking water. Inequities in water are commonplace all over the world. The irrigated valleys in California are short of water or already dry or salted out. Water, not oil, is our major problem for the future.

Some thoughts about water:

- It takes 26 gallons of water to produce a pound of tomatoes.
- One pound of asparagus requires 250 gallons of water,
- and a single almond requires a gallon of water for production. Think about that when you eat an almond.

We only think about water when we can't get it, but it is destined to become more precious and more controversial as we try to feed the increasing world population. As **Will Rogers** put it long ago, "Whiskey is for drinking, water is for fighting over." We can all make a difference using drip irrigation, short showers, and maybe not-so-green lawns. As young Chad showed us, one person picking up garbage can make our rivers much better resources. One person conserving water can also make a difference.

## A BIT OF HISTORY

ARCSE members and others often contact ARCSE support staff searching for information about the Civilian Conservation Corps (CCC) and specifically for enrollee records. This article gives a brief history of the CCC, introduces the CCC Legacy, and provides information about where enrollee records are maintained. Web links are provided for information about obtaining copies of records.

**Brief History of the CCC:** In 1932, one-fourth of America's men between the ages of 15 and 24 could not find work. Another 29 percent worked only part-time. Incoming President **Franklin D. Roosevelt** proposed on March 21<sup>st</sup>, 1933, that Congress create "a civilian conservation corps to be used in simple work, not interfering with normal employment, and confining itself to forestry, the prevention of soil erosion, flood control and similar projects."

When the Soil Erosion Service (SES) was created in the Department of the Interior on September 19, 1933, its new director, **Hugh Hammond Bennett**, wanted CCC camps assigned to his new agency. He planned to carry out watershed-based demonstrations of soil and water conservation. The CCC enrollees could be invaluable in helping farmers install soil conservation practices.

During the life of CCC, SCS supervised the work of more than 800 of the 4,500 camps. Black enrollees worked in more than 100 of those camps. SES, and later SCS (Soil Conservation Service), supervised this work. Also, a number of former enrollees, having learned soil conservation methods, became SCS employees. The CCC was an important element in Bennett's success in creating the soil conservation movement.

- To earn funds for CCC Interpretive displays for the new CCC Interpretive Center
- To develop educational programs that will teach citizens of all age

- To support the preservation of CCC heritage
- To strengthen the CCC legacy

## ARCSE Budget and Membership Report for FY 2016

As of July 1<sup>st</sup>, 2016, ARCSE's membership was 915. This is a 48% decrease from the high of 1,768 members in 1998. Over the last eight years, membership has decreased by 306 members, at an average rate of 3.2% annually.

There were 37 new members in FY16, 22 more than FY 15. 20 new members were complimentary. Nine of the 10 complimentary in FY15 joined in FY16. There were 31 members dropped at the May 1<sup>st</sup> cutoff. There are 799 newsletters distributed by email, 92 of which are distributed to NRCS leadership. 231 newsletters are distributed in hard copy.

## Analysis of Current Finances

At the rate of asset depletion over the last few years and membership decrease, ARCSE's existence had become unsustainable. The Board and current membership has addressed this over the last fiscal year by:

**Appeals for contributions.** Annual contributions help, and a strong appeal in FY2012 and in FY2016 resulted in significant response from membership that nearly balanced the budget in 2012 and in 2016 resulted in a significant replenishment to the reserve of \$3,648.72.

**Distribution of the newsletter electronically.** Over three fourths of the membership now receives the newsletter by email, and this has reduced the publication and distribution costs by 54% and the total expenses by 38%. Why not more? Over the last three years (as the number of copies printed has decreased from 1,160 to 230) the average cost per page for printing has increased by 28% and the number of pages per copy has increased by 35%. This increase in number of pages is for the most part due to a significant increase in the number of photos—much appreciated by membership. The editor does decrease the size of photos for the printed version. This sometimes saves four pages.

## Current Actions by the Board Related to the Printed Newsletter.

During Board meetings on July 25 and August 16, 2016, the following motions were adopted:

- Printed and mailed copies of the newsletter will be provided only to members who pay an additional fee of \$12 per year above the lifetime or annual dues payment.
- Only the electronic newsletter will be provided with the complimentary one year membership.

The Board sees these actions as necessary to place ARCSE on a more sound financial footing. They will become effective on January 1<sup>st</sup>, 2017.

707 members (77% of our membership) currently receive the newsletter electronically. Over 60% of the 231 members currently receiving hard copies of the newsletter have agreed to either switch to the electronic copy or pay an additional fee, or are already making contributions to cover the additional cost. The Board's action allows those members who prefer the hard copy, or do not have adequate service to receive the electronic copy, to keep receiving the printed newsletter by mail. Measures will be taken to credit those members who have already made contributions to cover their printed copies in future years. These measures will be described in both the November newsletter and in the dues notices that will be issued with the November newsletter.

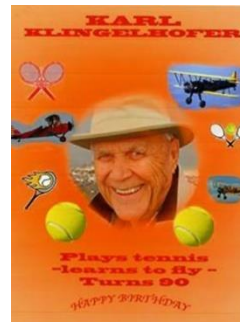

**Lyle and Charlotte Asell** recently attended a reunion of his Viet Nam Army unit in Golden, CO. Lyle was part of the 579<sup>th</sup> Terrain Intelligence Detachment Unit (Viet Nam) where he served in 1967-68. Lyle provided the following information about the reunion

and his service in Viet Nam. He told me to edit as necessary, but this is so interesting that I'm including all of it. Thank you, Lyle, for your service and also for providing the following:

"We (the 579<sup>th</sup> Terrain Intelligence Detachment Unit) were unusual for several reasons. We were small, usually around 11 guys. Virtually everybody had a degree, ranging from BS to PhD. We were older than most GIs. We each had an area of technical expertise, regardless of rank. We provided data to military units on construction material (laterite, rock, bamboo, etc.), mapped tunnels; predicted floods; evaluated roads, bridges and old French bases; mapped vegetation (ranging from Elephant Grass to triple canopy jungle); etc. We had geologists, mining engineers, civil engineers, soil scientists, agronomists, foresters, geophysicists, and, of course, biologists.

One memorable mission was so top secret even our CO didn't know where four of us were. The mission was to Khe Sahn, near the DMZ, where we were with a Marine Long Range Recon company to gather data for what became known as **McNamara's** electronic barrier across the DMZ. My part was to map vegetation which would affect which sensing devices would be deployed. (Since we were sternly warned not to tell anyone about the mission, and my unit didn't know where I was, I went without mail or pay for a month. Two weeks after returning to the 579<sup>th</sup> I was sent to DaNang with two other guys to predict floods on 18 rivers in I Corps. Since we did not control the mountains where runoff occurred, we had no data to work with and were told to do the best we could. For three months we had nothing to do, and to top it off, my pay never caught up with me. Luckily **Dave Nelson**, one of the reunion organizers, floated me a few loans. (I think I even paid him back).

There were nine members at the reunion (I served with eight of them) and five spouses or their children. We had a great time remembering various events and telling stories, which were amazingly consistent. When you spent a lot of time together, as we did in a situation far from home, you get to know each other pretty well and develop friendships. Then life happens and you don't see each other for 48 years, but it is amazing how fast you reconnect.

Lives after Viet Nam were interesting, and many members of the 579<sup>th</sup> were/are outstanding in their chosen fields, be it education, mining, business, public service, etc. One of the guys attending the reunion was **Roger Hammer** who spent most of his career as a Soil Scientist for SCS/NRCS in Nebraska. One of the guys tried to identify those who served in the 579<sup>th</sup> which was in Viet Nam from 1966 to 1970. Veterans of the 579<sup>th</sup> came from all over the US and attended many universities. Iowa State University and Colorado School of Mines provided more than any other university, with one guy who received degrees from both."

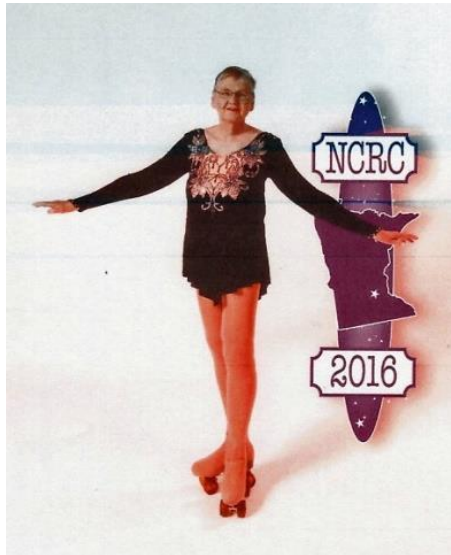

They use a lot of mud to build that many houses. **Mary Ann** and I decided it would be great to have a pond not too far from the house so we could water the cows, and if it works out right, plant some fish. However, it's tough to make ends meet out here on the farm, so we will contact NRCS to see if we can secure an Environmental Quality Incentive Program contract to build the pond.

If NRCS approves the contract, we plan to till up the area where we want the pond and sprinkle it so the soil is moist. The Barn swallows would then use the area to dig out the mud to build their houses. It's going to take a few years for the Barn Swallows to dig the pond but we will keep the area moist where the soil needs to be removed. I'm going to ask NRCS for a copy of the Pond Standards and Specifications and we will post them on the barn so the Barn Swallows will know what they need to do to make sure the pond is built right.

There are a lot of plusses in having Barn Swallows around. Mary Ann is able to gather a lot of eggs. They taste real good, but it takes eight Barn Swallow eggs to equal the size of one chicken egg. The other thing is that the Barn Swallow droppings are fertilizing the yard. Mary Ann parks one of her wheel barrows under an eave. She then put a sign on the wheel barrow that says "Bird Bathroom." The birds understand what that means since she has had to dump the wheel barrow several times. I've also seen a lot of robins, killdeers and sparrows fly over and bomb the wheel barrow. When it's half full, Mary Ann uses the droppings to fertilize the crops. Barn Swallows are a real valuable farm animal. They dig ponds, furnish eggs, fertilize the yard and eat a ton of mosquitos. Plus we don't have to buy bird food to feed them. And we don't have to pay them either.

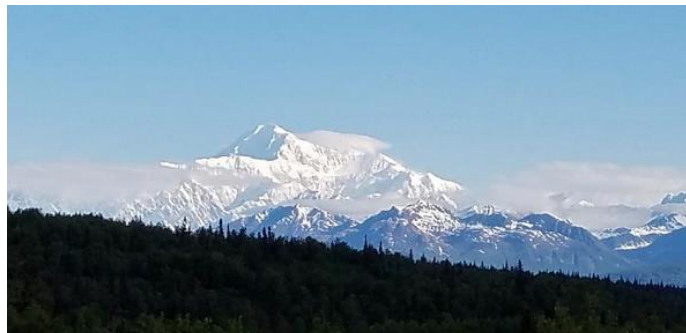

We first did the land tour for six days and then the sea cruise back through the inner passage for six days. Two of the 12 days were travel to and from Alaska. We did get to see Mt. McKinley (or Denali as now named) several times. Weather was very cooperative. Some people have been there to see Denali three times and have never actually seen it because of the weather conditions. Visitors to Denali have about a 30% chance of actually seeing the mountain. We did a wilderness tour through Denali National Park and took the train back to Whittier to begin the cruise part of the trip. The highlights of the land tour were a fabulous glacier-landing flight by small airplane and horseback riding.

Highlights of the cruise part of the trip were a whale-watching trip out of Juneau and several glacier-viewing trips. The whale-watching trip was awesome. One whale breached (jumping out of the water, usually accompanied by spins) 15 times (I kid you not—as counted by the tour guide, not by me). We viewed several glaciers way up Glacier Bay, including the Margerie and Grand Pacific Glaciers with active calving. I was surprised there were no large icebergs like in the North Atlantic. We then had stops in Skagway where we took the White Pass and Yukon railway up the long pass taken by past gold miners.

We also had a stop in Ketchikan, where we took a tour of the island before arriving at our final destination in Vancouver. Sea trip covered 1,700 statute miles."

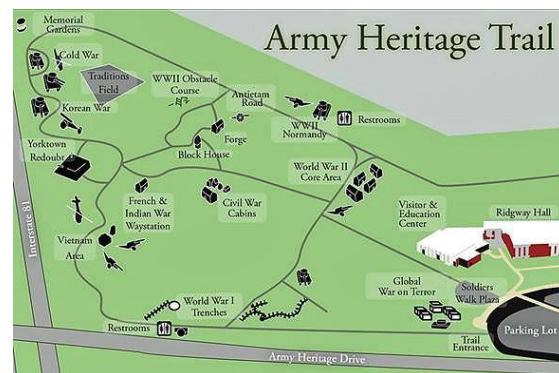

### Senior Conservationist Johnny M. Eubanks

Senior Conservationist **Johnny Eubanks** was born May 9<sup>th</sup>, 1932, in Tate, GA. Tate is in Pickens County, GA, about 56 miles north of Atlanta. Johnny's father worked for Georgia Marble and inspected every piece that was cut for the east wing of the United States Capitol. Although not directly involved in farming, Johnny was interested in agriculture from a young age. He graduated from Tate High School in 1948 and entered Berry College in Rome, GA, in the fall of that year. He graduated in May of 1953 with a B.S. degree in agriculture (animal husbandry major and agronomy minor).
