The ARCSE annual board meeting will be at the Des Moines, Iowa convention center on August 7th. During the meeting, I will transfer the gavel to **Julie MacSwain** who has served as president elect during the past two years. She will do a great job and is full of ideas to improve ARCSE in various ways. Being sustainable is a major concern, which is directly related to increasing memberships. Outgoing ARCSE Past-President to be SWCS Liaison

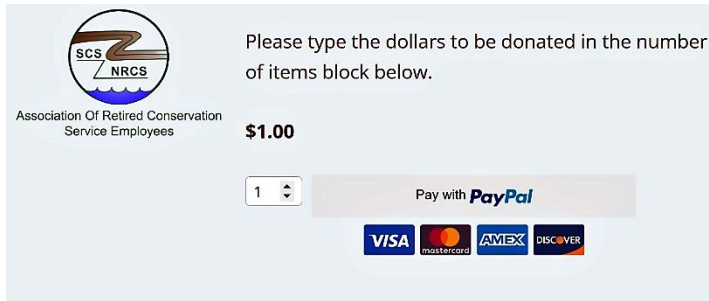

ARCSE Annual Meeting

Each year ARCSE holds its annual meeting at the site of the SWCS International Conference. Remember that "save the date" message from a few weeks ago? That was for this meeting which will be held in Des Moines on Monday, August 7th. The meeting will be at the Community Choice Credit Union Convention Center located at 833 5th Avenue in downtown Des Moines. The SWCS website link shown below has a map to the Convention Center.

The ARCSE/retirees meeting will be from 3pm to 5pm in Boardroom 2 on the Mezzanine Level. This meeting is for all ARCSE and non-ARCSE members to attend at NO cost. A copy of the agenda for the meeting is attached. Chief **Terry Cosby** has been invited to attend. The feeling is that he will be there but has not been confirmed yet. I know many of you knew and/or worked with Terry when he was here in Iowa. While sometimes, based on my experience, discussions on Memorandums of Understanding and Strategic Plans can help cure insomnia, believe me, these presentations will present some interesting ideas and opportunities for any of you who may want to get involved.

The Awards presentations will also have a little Iowa flavor. However, the highlight of the meeting will be a presentation by **Lyle Asell** and **Kevin Kuhn** on the history of agriculture in Iowa and some discussion on where we may be headed. These guys both have a lot of knowledge and expertise about our agriculture – past, present, and future. Remember, there is no cost to attend this part of the meeting.

SWCS has invited our retirees to attend this session. This will provide a great opportunity for more "catching up" with each other as well as discussing conservation with conference exhibitors and poster presenters. There will be hors d'oeuvres provided at this session. You must register to attend this session. Following are three scenarios for registering:

1. If you are an SWCS member and have or will register for the SWCS conference, this session is included in your registration.
2. If you are an ARCSE member and not attending the SWCS conference, there is a \$35 fee for attending this session. To register, use the following steps:

 - b. In the box that says "Enter Access or Discount Code" type in **23ARCSEMEMBER** and select apply. Note: This box is at the very beginning of the list of the types of Tickets.

- c. Scroll near the bottom until you see the “Guest Ticket(s) for Exhibitor and Poster Reception” at the \$35 rate and select the number of tickets you need.
 - d. Select “Get Ticket” on the right side of the screen and continue with the registration process.
3. If you are not an ARCSE member and are not attending the SWCS conference, there is a \$50 fee for attending this session. (Note: this could be a really good time to join ARCSE!). To register, use the following steps:
- a. Visit <https://registration.socio.events/e/swcs23ac>
 - b. Go to the list of Tickets and scroll near the bottom until you see the “Guest Ticket(s) for Exhibitor and Poster Reception” at the \$50 rate and select the number of tickets you need.
 - c. Select “Get Ticket” on the right side of the screen and continue with the registration process.

If you plan to attend only the ARCSE/retiree meeting (3pm to 5pm), you do not have to register. However, to help make sure there are adequate facilities, like chairs, etc., please respond back to me so I can provide the ARCSE Board and SWCS with an estimated number of folks who will be there. For this number, I'll also need to know of others coming with you, for example, a spouse or friend.

Courtney Allen with SWCS said that she will make sure the registration for the Exhibitor and Poster session remains open until the July 26th registration deadline at the same costs of \$35 for ARCSE members and \$50 for non-ARCSE members as it has been through the early bird registration period. There will be late registrations allowed after July 26th, but the cost will be at the full price of \$75.

Debt Ceiling Crisis Resolved

After weeks of heated negotiations, **President Biden and House Speaker Kevin McCarthy** reached agreement on a deal to raise the debt ceiling limit days before the June 5th, 2023 deadline. President Biden signed H.R. 3746, the “Fiscal Responsibility Act of 2023,” two days before the fiscal deadline.

According to a New York Times article dated June 2nd, 2023, the bipartisan deal suspends the nation's \$31.4 trillion borrowing limit until January 2025. The agreement suspends the debt limit for a period of time, but it does not set the debt limit at a new fixed level. The deal essentially gives the Treasury Department the latitude to borrow as much money as it needs to pay the nation's bills during that time period, and a few months after that date to allow the department to use accounting practices to continue payments.

The White House estimates that the agreement will yield \$1 trillion in savings over the course of a decade from reduced discretionary spending.

Following are some of the key components of the bill.

Lifting the debt ceiling. The deal reached by **President Biden** and **Speaker Kevin McCarthy** will suspend the nation's debt limit until January 2025. This will allow the government to keep borrowing money so it can pay its bills on time.

Spending caps and cuts. In exchange for suspending the debt ceiling, Republicans demanded a range of concessions. Chief among them are caps on some spending over the next two years. The deal also claws back \$10 billion in I.R.S. funding.

Food stamps. The legislation places additional work requirements on older Americans who receive assistance through the Supplemental Nutrition Assistance Program (SNAP), but it also expands food stamp access for veterans and homeless people.

Student loans. The legislation will officially end Biden's freeze on student loan repayments by the end of summer. It will also prevent the president from issuing another last-minute extension, as he has done several times.

Environmental impact. Both sides agreed to new measures to get energy projects approved more quickly. The deal includes a win for **Senator Joe Manchin** of West Virginia, a Democrat who strongly supports fossil fuels, by fast-tracking the construction of a contentious pipeline.

Leaders of Agriculture Committees Issue Joint Statement on Next Farm Bill

On May 11th, 2023, Ag Committee Chairman **Glenn "GT" Thompson** (R-PA), Ranking Member **David Scott** (D-GA), **Senator John Boozman** (R-AR), and **Senator Debbie Stabenow** (D-MI), issued the following statement.

*"Today, the four leaders of the Agriculture Committees had a conversation with President Biden and **Secretary Vilsack** on the importance of passing a bipartisan Farm Bill this year. The Farm Bill is a jobs bill. It is a safety net for farmers and consumers, and it is an investment in our rural communities and the health of the American people. The Agriculture Committees have a long tradition of bipartisan cooperation, and we look forward to continuing that tradition through our work on the 2023 Farm Bill."*

Nebraska Delegation Discusses Work on New Farm Bill

U.S. Representatives Don Bacon, Mike Flood, and Adrian Smith and **U.S. Senator Deb Fischer** met with University of Nebraska agriculture researchers on Monday, June 19th, 2023, in Lincoln, NE.

The Nebraska Examiner news reported on June 20th, 2023, that **Senator Fischer**, who serves on the Senate Agriculture, Nutrition and Forestry Committee, said "the need to negotiate an agreement that addresses both rural and urban concerns could push the new bill into 2024. She said it might take months to hammer out the specifics of a deal that will meet the needs of multiple interests."

Republicans in the House and Senate have been pushing for discretionary spending cuts during and after recent debt ceiling negotiations. Some critics of the budget deficit situation have focused on the cost of the current 2018 farm bill, which cost taxpayers an estimated \$800 billion over a decade, according to some estimates.

Much of the expense of the Farm Bill is used to pay for nutrition programs, including school lunches and the Supplemental Nutrition Assistance Program (SNAP), formerly known as food stamps, which help secure urban support for farm programs. All five members of Nebraska's delegation were asked how they square their support of spending cuts with support for farm programs. Several said that while they want to cut federal spending, they would prefer to cut programs that they consider less effective.

Congressman Mike Flood said the Farm Bill has helped keep food costs lower for Americans and boosts the ability of U.S. exports to compete for international customers. "Sometimes we take our food security for granted," said Flood. "Sometimes we take the fact that we use less than 10% of our annual income to pay for our food, which is a lower number than almost any other country on earth." For more information see

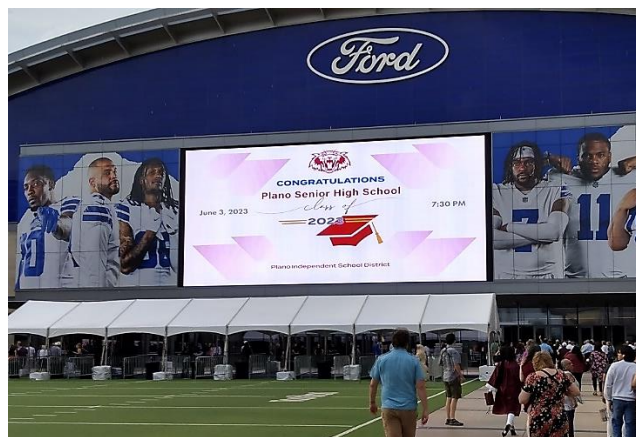

The nose of **Ozcar** the beagle and those of nearly 200 other detector dogs know best when it comes to keeping prohibited fruit, vegetables, plants, and meat products from high-risk countries from entering the United States.

According to U.S. Customs and Border Protection, a detector dog can scan a piece of luggage for smuggled or forgotten fruits in mere seconds — making them a key tool for screening passengers and cargo to prevent harmful plant pests and foreign animal disease from entering the country.

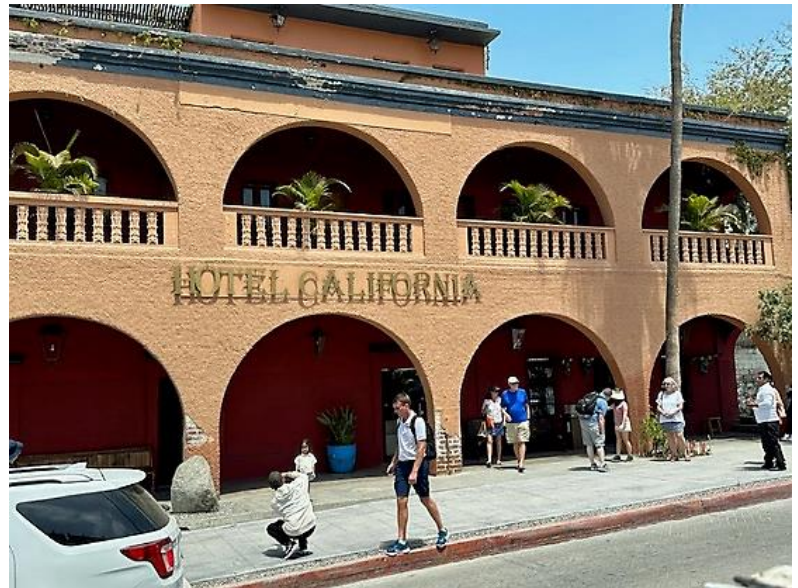

A Dream Come True a World Away | Natural Resources Conservation Service, March 14th, 2023

Many years ago, and in a land far away from Texas, a young girl lived with her parents on a small farm in Kenya, where they ran a small herd of cattle. She was raised taking care of those cows, with the charge of feeding and milking them daily.

"I had strong desire to one day own land and raise cows of my own," said **Elizabeth Thinwa**, sharing the seeds of her lifelong dream first in her native Swahili language before carefully and delicately translating each and every word to English.

In 2014, she explains, her dream came true and Thinwa was able to buy 142 acres of land, now known as Beth Ranch in Waco, Texas.

Thinking back to her days on her parent's farm, Thinwa explains her parents' cows helped the family economically.

"I liked cattle right from when I was little because they provided money for me to go to school. So, I knew it was a good business," she said.

It was her experience there and that dream of owning her own land and her own cows that would eventually bring Thinwa from Kenya nearly 9,000 miles across the world to the United States. Welcome to Texas.

"I migrated to the United States here in Texas in 1995, and at that time I was working in a formal employment, still pursuing my dream and my desire to one day be able to secure a piece of land for myself and raise cows, especially beef cows."

It wasn't until Thinwa sought information through the local McLennan County Extension Office that she gained a sense of what direction to take. She was referred to the USDA Natural Resources Conservation Service (NRCS) whom she was told would come out to help her implement a conservation program to improve the ranch and her herd. Of the 142 acres on Beth Ranch, 136 acres are being used for the operation of raising beef cattle. NRCS would provide guidance on how to manage that plot of land, and in turn, raise healthy cattle.

She recalls meeting with NRCS District Conservationist **Clete Vanderburg** for the first time, whom she describes as being very eager to provide technical assistance, as well as help build her a conservation plan. He went through the different conservation practices, identifying the Environmental Quality Incentives Program (EQIP) as an appropriate program for her land. They met at Beth Ranch and talked through what needed to be done, and he designed a plan for Thinwa in terms of brush management to improve the grass as well as to improve her water system to make it more efficient. Cross fencing also came up, so Thinwa could improve her pastures for rotation.

As far as she has travelled in life thanks to some big dreams as a small child, it seems as if Thinwa is just getting started. And like her dreams, the possibilities that lay ahead seem endless.

"Truly, I want to be an inspiration to many people. Not just my family, but to other people out there," she said. "They'll be inspired by a little girl dreaming and having the dream come true."
